*Tuition fee is charged by **quarter, not** on a **daily or monthly** basis. The payment should be made by quarter and is due at the beginning of the quarter. However, to ease the burden in paying the quarter tuition, the School Board allows payment by month in the following schedule of payments. **Generally, paid quarterly tuition is non-refundable.***

Initial Enrollment Fee is a one time fee for grades KG2 - Grade 12 and is due upon acceptance.

Testing Fee is an as needed pre-enrollment test fee and is due when the test is taken. Upon acceptance, the fee is considered a tuition pre-payment.

Transportation Fee of SR 3,650.00 is a lump sum non refundable fee and is due on or before October 31, 2010.

EAP payments are to be paid in lump sum upon receipt from employer. The fees in excess of EAP allowance are payable in two (2) equal installments as follows: First Installment due on..... October 31, 2010
 Second Installment due on..... January 31, 2011
